## **Subject: Guidelines for Lateral Entry Admission in Paramedical Courses**

Sir/Madam,

This letter is to officially inform all affiliated institutions that the **Paramedical Education & Training Council** permits **Lateral Entry Admissions** in all paramedical certificate courses approved under its guidelines.

Lateral entry is allowed for eligible candidates who possess prior relevant academic qualifications or work experience, enabling them to join the program from the second year or final phase, subject to council approval.

### **Courses Applicable for Lateral Entry:**

All council-approved courses including (but not limited to):

- Diploma in Medical Laboratory Technology (DMLT)
- Diploma in Operation Theatre Technology (DOTT)
- Diploma in Community Medical Services & Essential Drugs
- Diploma in ECG & CT Scan Technology
- Diploma in X-Ray & Imaging
- Diploma in Physiotherapy
- Diploma in Dialysis Technology
- Diploma in Ophthalmic Technology
- Diploma in Nursing Assistant / GDA
- Certificate in Emergency Medical Technician (EMT)
- All other approved paramedical diploma courses

### **Eligibility Criteria:**

- Completion of a **certificate course** in a relevant field from a recognized board or institute.

### Required Documents:

1. Mark sheets and certificates of previous qualifications
2. 6 month to 1 years relevant course internship (if available )
3. Government-issued ID and address proof
4. Lateral Entry Admission Form (as prescribed by the council)
5. Undertaking or declaration
6. Enrolment & Examination Form

### Important Guidelines:

- Admission through lateral entry must receive **prior approval** from the Council.
- Candidates shall be exempted from first-year exams and appear for final exams only.
- Certificates will state "**Lateral Entry**" mode of admission.
- **Backdated admission or registration will not be permitted.**

Affiliated institutions are requested to inform students accordingly and submit necessary documents for lateral entry candidates during the admission and registration process.
